

Terms of use

Lenzing AG (Lenzing) or other Lenzing group companies hold(s) the proprietary rights to this website and all other Lenzing websites. By accessing and using this website, the user is subject to the following Terms of Use:

1. The use of this Lenzing website as well as the use of other connected websites, or documents and files accessed through this website by the user is permitted for personal information purposes only.
2. The Lenzing website(s) as well as all content placed on the Lenzing website(s), in particular [any] information, data, text, images, graphics, signs or marks, are protected by copyrights or by other intellectual property rights and are exclusively intended for the information of the user only.
3.
